La Rochelle

La Rochelle (80,000 inhabitants) is a touristic city on the French Atlantic coast. The municipality aims to be a slow town, meaning that 80% of the streets will be limited to a speed of 30 km/h in the coming 2 years. The idea is not to struggle against the car, but to show solutions and offer people the opportunity to experience life without the car, change behaviour and perspectives and be thus able to imagine a different use of the public space.



2016: the main principles

The 1st october 2016:


•Adapt price lists practised on street according to the evolution of price lists seen again in the public parking lots (public road network more expensive than parking lots),


Propose price lists on allowing public road network of : -To offer the possibility of the car park of the very short-term visitors on the public road network (price dissuading illegally parked cars), -To incite the medium to long-term visitors, in particular the tourists for underground and surface car parks, and so decrease the traffic generated in the hypercenter by the users looking for a place, -To incite the pendular and the tourists to use the P+R, -To allow the residents to park near their place of residence on street, -To propose subscriptions which are coherent and readable

1st october 2016: what has changes

The logic of the car park is made by concentric circles going of most expensively to the hyper-center until the least expensive as we shall go away from the city heart It can be put forward:

- ✓ The reduction in price lists parking lots,
- The reduction in parking fees lists on street for people living in center,
- A parking fee increase in coherent public road network by comparison with other municipalities, so allowing a regular staff turnover to favor the economy of the businesses of city center.



1st january 2018: what has changes (1/2)

Implementation of the new Law MAPTAM (decriminalization) by adapting the maximal duration of authorized car park (2h00 in orange area and 7h30 in green area) and by setting up the post parking package (FPS) as a Fee of occupation of the public domain

- ✓ Payment of the FPS in 30€, underestimated in 17€ if payment within 72:00 am
- Agents equipped with a printer in the belt to emit the FPS
- The user can pay in the parking meter, on the Web site of the city, by mobile solution or to the ticket office
- ✓ Before, it was national and the fine, fixed by the State, was 17€ and it was of the penal
- \checkmark Now, the municipalities fix the amount of the FPS
- Dematerialization of tickets




1st january 2018: what has changes (2/2)


